This newly updated file features 1,489,911 non-profit, tax-exempt clubs, organizations, societies and associations in the U.S. Non Profit Clubs and Organizations qualify for exemption from federal corporate income taxes. The U.S. Internal Revenue Code contains more than 25 different classifications of tax-exempt groups, including professional associations, charitable organizations, civic leagues, labor unions, fraternal organizations, and social clubs, to name just a few.

Depending on the category of the exemption, such groups are entitled to certain privileges and subject to certain reporting and disclosure requirements and limitations on their activities. In certain instances, contributions to non-profit organizations are deductible from federal income taxes.
