In addition to this preparatory work, Paralegals, Legal Assistants and Legal Secretaries perform a number of other functions which could include: drafting contracts, mortgages, and separation agreements, preparing tax returns, establishing trust funds, and planning estates. Some Paralegals, Legal Assistants and Legal Secretaries coordinate the activities of other law office employees and maintain financial office records.
